



In the world of dentistry...

The global oral health crisis affects 3.69 billion people worldwide. Dental caries remains the most prevalent disease, affecting around 2.24 billion people, with severe periodontitis impacting 1.07 billion and complete tooth loss affecting 353 million individuals. Meanwhile, the WHO reports that oral diseases affect 3.5 billion people globally, underscoring an ongoing public health challenge.

The future of cosmetic and digital dentistry is tech driven. By 2045, cosmetic dentistry may emphasize ultra-thin "no-prep" veneers, LED therapies, oral probiotics, and regenerative techniques aligned with skincare trends. Additionally, the dental industry is rapidly adopting digital



tools:

- AI-driven diagnostics, predictive analytics, and chatbots
- Personalized care via digital smile design, bioprinting, and genetic testing
- Wellness integration (e.g., dietary counseling, stress management)
- Enhanced patient experiences through AR, VR, and seamless digital communication.

The dental workforce is growing. By 2028, the U.S. dental workforce is projected to grow by 10,400 new dentists (a 7.6% increase), driven by population growth, evolving healthcare laws, and retirements. Most dentists (about 80%) practice general dentistry; only 20% specialize.

I look forward to a strong finish, concluding a productive year and I am looking forward to seeing you at an event soon.

So, what's the other problem?

Last bulletin I shared observations on the membership market share decline, crisis management that works in large organizations and the particular challenge that volunteer organizations like ours, face. I outlined solutions that I believe can work based on my experience with crises in large organizations. But this time, I'm going to share a problem that I don't have a concrete answer for. It is the issue of local leadership and involvement in the society. It's my understanding that 20 years ago there was a solid pipeline of leaders here in Suffolk County Dental Society. Individuals who were interested in the profession, steering it and having genuine influence on local matters. There was a culture of involvement, engagement and volunteerism such that a healthy competition existed for various roles in the society locally as well as at the state and national level. Indeed, these individuals would rise to even more impactful roles beyond Suffolk County. It was like a cottage industry existed here, where expertise and a drive to succeed were cultivated. The more experienced leaders guiding the newer who in turn would do the same. They all experienced great satisfaction from the work they were doing in organized dentistry. Their colleagues would take note and thus the colleagues would get involved. The comradery was strong, attachments of the individuals to each other fueled the desire to meet, work and achieve. The pump was primed and it ran beautifully, for a more organic metaphor, things just continued to blossom.

These days, we still have wonderful leaders, but the pipeline is thin and getting thinner. We have a great board of directors. However, we don't see individuals progressing to the next step which would normally be a "ladder" position, progressing up to President of the Suffolk County Dental Society. We certainly know that times change, things evolve and we must as well. Our bylaws allow for this and



adaptation is in progress (as it has been in previous years). At the ten-thousand foot level, graduating dentists are about the same age they have always been, they have a ton of debt, they may be looking to marry, buy a house, start a family, buy into a practice or find a job that affords them the right work-life balance. Those are some super-hefty things, and while you might ask "is that very different than 20 years ago" the short answer is NO. But the right answer is YES. Here's some quick numbers 2005 vs 2025:

Avg Dental Salary - \$139k/\$205k – up 47%

Avg D.School Debt - \$130k/\$300k - up 131%

Avg Home Cost Suffolk - \$400k/\$700k- up 75%

There are still 24 hours in a day, but maybe this explains some reluctance in recent graduates, but still if this is you, we have a great fit for you. And, what about those that have been practicing ten years? The forty-ish folks, where are you? What can we do to have you engage and positively impact the profession in the way you feel is necessary? Come on down, bring a colleague, be part of your own personal and professional renaissance.



Member Spotlight: Dr. Junaid Mundiya, Oral Surgeon—When Oral Surgery Meets Organized Fun



For Dr. Junaid Mundiya, dentistry offered the perfect mix of medicine and



entrepreneurship. Growing up in a small business-oriented family, he appreciated the independence and responsibility of running something of his own, while also feeling a strong pull toward healthcare.

“Dentistry, and ultimately oral surgery, became that perfect blend of hands-on medicine, immediate patient impact, and the ability to shape your own path.”

One of the most rewarding aspects of oral surgery, he says, is the chance to provide immediate relief. “We see patients in some of their most uncomfortable moments and are able to provide immediate relief. Unlike many other medical specialties, we aren’t dealing with life-and-death situations every day. That gives us the privilege of helping patients without carrying the constant emotional weight of mortality.”

Dr. Mundiya first encountered organized dentistry in dental school through ASDA, where leadership meetings gave him an early appreciation for advocacy and community. When he joined Suffolk Oral Surgery, his mentors were active in the Suffolk County Dental Society, and he quickly followed their lead. “Dentistry can feel isolating, but organized dentistry connects you with colleagues who live the same life. You can share the good, the bad, and the ugly with people who truly get it. That kind of support system is invaluable.”

Today, as a member of the SCDS Board of Directors, Dr. Mundiya believes one of the Society’s greatest responsibilities is advocacy

- both for patients and for the profession.

“Patient access to care and raising awareness of the value of dentistry are critical. Organized dentistry ensures our voice is heard on issues like policy, insurance, and legislation.” On a personal level, his involvement has helped him build strong professional relationships that directly impact his practice. As an oral surgeon, he knows collaboration and trust with general dentists and specialists is essential to providing the best patient care. SCDS has been an invaluable platform to developing many of those connections.

When asked about the changing dental landscape, he remains grounded in a simple philosophy: “Treat every patient like family. If





you do that, it doesn't matter whether you're in private practice or a DSO-you'll always be doing the right thing."

To young dentists and dental students, his advice is clear: get involved early. "Organized dentistry isn't just about networking. It's about building lifelong relationships and learning from the experiences of others-lessons you won't find in a textbook."

Outside of work, Dr. Mundiya stays grounded by prioritizing family time. "My kids remind me why I work as hard as I do." And after all these years, what keeps him excited about his profession? His response is immediate: "Honestly, it's fun. Every day is different, and every patient is unique. That variety, combined with the chance to make an immediate difference in someone's life, keeps me energized."

Ninth Letter from the ADA Second District to the NYSDA Components

Trustee's Corner

It's hard to believe but summer is coming to an end, and we are closing in on the end of the first quarter of the twenty-first century. Personally, I have officially retired from the University of Buffalo School of Dental Medicine after being a faculty member for eighteen years. Overlap that with thirty years of private practice and I can honestly say it has been a wonderful ride. I will continue to serve the Second District as your Trustee until the annual meeting next year in Indianapolis. Congratulations to my colleague, Dr. Payam Goudarzi, on his selection as the next Trustee for New York State. As I have mentioned before, it has been an honor and a privilege to serve the profession at the American Dental Association.

You recently received several correspondences from the ADA about our current finances. Suffice to say, adjustments were needed to this year's budget. With the leadership from our Finance Committee, the Board of Trustees approved an approximately \$20 million dollar reduction from the 2025 budget. There were some very difficult decisions made with eliminating and pausing specific ADA programs and laying off several hard-working employees. The Board of Trustees knows this is a difficult time, especially for the people who worked or volunteered with these programs. Included in these reductions were daily travel stipends for Board members as well as the elimination of spouse travel stipends. We also added the Chair and Vice Chair of the Strategic Forecasting Committee as consultants to the Finance Committee. We appreciate your support, understanding and patience during this time. Unfortunately, there is still a deficit as we plan for the 2026 year. The Board began the process of putting the 2026 budget together at the end of August at our meeting in Chicago. We will continue to keep members apprised of our financial situation through leadership communications, the ADA Treasurer's Letter, as well as the ADA Reader Leader and the ADA Power of Three Emerging Issues Webinars.

The Fonteva Account Management System, which began in September of 2024, is undergoing a corrective implementation. It was a difficult beginning, and problems were uncovered in late 2024. Since that time, there have been some noted positive results around the country, with a few states coming along at a slower pace. Unfortunately, the New York State Dental Association is part of the latter cohort. The ADA has established a PMO (Project Management Office) to monitor, oversee and measure this project with the help of an outside agency, Crowe LLP. There is also a Steering Committee to oversee the entire project. Our goals include stabilization of 90% of the data entries for October renewals, make it seamless for members to pay for events and register for continuing education, as well as fewer errors and reduced support needs. The ADA IT team is working with the NYSDA IT and membership teams to improve the AMS as it pertains to the New York State Dental Association. I would like to thank the staff at NYSDA for their hard work and contributions to this project and helping it become successful.

As many of you heard, a decision was made to make the 2025 SmileCon in Washington, DC the last SmileCon celebration. Unfortunately, the event has lost a substantial amount of money the past several years and the Board of Trustees felt the financial results were not going to change. The House of Delegates will still meet in Indianapolis, Indiana, October 10th – 13th, 2026 and plans to have the annual scientific session in the same location are in discussion. The ADA is required under the Bylaws to have a scientific session every year. The House of Delegates will still take place in Denver, Colorado, October 29th – November 1st, 2027.

The ADA Membership Engagement Model program that is taking place in four states (New Hampshire, New Jersey, New Mexico and Washington) and Washington, D.C., following the accelerated transition to the AMS/CRM (Fonteva/Salesforce), has shown a small improvement in membership numbers. Although it is early in the three-year pilot and we will have more information with the completion of the implementation of the Fonteva Association Accounts Management System, it is a promising sign that the ADA is heading toward the correct value proposition for membership in our Association. At this point, it was decided to pause the addition of other states to the pilot for one year. Results of the pilot from the first year will be available soon.

I would like to take a moment of personal privilege to congratulate our own Dr. James Wanamaker from the Fifth District for his contributions as the New Dentist Committee member of the ADA Board of Trustees. Dr. Wanamaker has represented NYSDA extremely well and should be commended for his leadership and representation of new dentists at the ADA. Organized dentistry is in good hands for many years into the future with leaders such as Dr. Wanamaker.


